



**LAW ENFORCEMENT TRAINING  
CREDIT BY EVALUATION  
FACT SHEET  
New Mexico**

Rio Salado College, a Maricopa County Community College in Tempe, Arizona, is proud to announce its Credit by Examination program in Law Enforcement Training. This program is for individuals who are interested in attempting to receive college credit for learning acquired, demonstrated, assessed by the New Mexico Law Enforcement Academy Board (NMLEAB).

**Eligibility:**

- Certified by the New Mexico Law Enforcement Academy Board since July 2002.

**Policies:**

- Students may attempt to earn 40 credits through the Credit by Examination process and seamlessly apply them toward the requirements for the Associate in Applied Science (AAS) in Law Enforcement Training or Bachelor of Applied Science (BAS) in Public Safety Administration degree program at Rio Salado College.
- These 40 credits constitute the required courses needed for the Certificate of Completion in Law Enforcement Training Academy.
- By signing the Credit by Examination application electronically, students are authorizing (NMLEAB) to release grading information to Rio Salado. Courses will be graded on both a letter grade "A, B, or C" and passing grade "P" basis. A grade of "P" is equivalent to a "C" or better and is not computed in a student's grade point average. (NMLEAB) records reflect scores to calculate a course letter grade of "A, B, or C" since July of 2002 only. Certification examinations administered prior to this date will be reported and transcribed with passing grades of "P."
- The fee is \$30.00 per credit hour (40 credits total \$1,200.00) and is not refundable after the evaluation process has been conducted (refer to second page for listing of courses). Fees are subject to change by the Maricopa County Colleges Governing Board.
- Credit earned through Credit by Examination is transferable to other colleges and universities at their discretion. It is strongly recommended that students check with their local college or university regarding credit transferability prior to applying.
- Allow 4-6 weeks for processing, upon receipt of application.
